**FOR IMMEDIATE RELEASE: ALPINE COUNTY FACILITIES WILL BE CLOSED TO THE PUBLIC EFFECTIVE FRIDAY, DECEMBER 24, 2021 AND ARE SCHEDULED TO REOPEN ON TUESDAY, JANUARY 4, 2022.**

The Alpine County Board of Supervisors voted to close all Alpine County Facilities to the public effective Friday, December 24, 2021 and will reopen to the public on Tuesday, January 4, 2022. Mandated County services will still be delivered during this time. **The Board of Supervisors meeting scheduled for January 4, 2022 has been cancelled.**
